## Please Read Plainridge Park Racing Application Conditions Carefully

In consideration of the privileges of racing and stall space being allotted, and entry in any races, in respect of all of the aforementioned horses by the company known as Plainville Gaming & Redevelopment, LLC (herein "Plainridge"), the applicant, who may be the trainer and/or owner of the above named horses or his/her agent and all persons for who he is acting, upon execution of this application agree, accept, and are bound by all the terms and conditions set forth.

## **Conditions**

- 1. Plainridge reserves the right, without any reason existing or being given, at any time:

  A) To refuse racing privileges or stall space to an applicant; B) To revoke and terminate without notice at any time, the privilege of racing or stall space at Plainridge; C) To refuse permission to enter and to race horses at Plainridge; D.) To refuse at any time the applicant and/or his employees or persons under his charge or control or any of them admission to the Plainridge backstretch, barn area, racing paddock or any other grounds of Plainridge;
- 2. The applicant agrees that prior to entering horse(s) for races at Plainridge he/she will furnish a current negative Coggins Test and other documentation that may be requested by Plainridge from time to time to ensure the safety of all participants.
- 3. All horses must have a valid electronic eligibility certificate through the USTA before entering to race or qualify. Horses entered in claiming events are eligible to be claimed under the claiming rules and regulations. Owners authorization of horses entered into and participating in claiming races is assumed upon entry and validated by starting in any claiming event.
- 4. The applicant agrees to enter the horses in his/her care as agent or owner in the conditions that have been written in their said class by the Racing Secretary.
- 5. Any pass issued at Plainridge to any person employed by applicant or under his charge or control, shall, upon termination of such relationship, deliver said pass to the Security or Judges Office at Plainridge for cancellation. Passes are issued for the personal use of the pass holders and are not transferable. Any passes transferred to another person will result in the removal of all parties involved from the grounds.
- 6. Only stalls specified by Plainridge are to be used by Applicant for racing, stabling or ship-in purposes. Applicant is to keep their stall and ship-in accommodations (including stalls, tack rooms, wash areas and shed rows) allotted in good and clean condition. Any damage caused to such accommodations by applicant will require applicant to reimburse Plainridge for any such costs prior to entering any horses at Plainridge in the future. All horses shipping in shall report the assigned stalls on race day.
- 7. The applicant agrees to be governed by and to obey the rules of racing of The Massachusetts Gaming Commission, the U.S. Trotting Association and when on Plainridge premises, the rules and regulations of Plainridge. The applicant is subject at all times to the Penn National Gaming, Inc. Racing Guide and any local guide and regulations as promulgated by Plainridge and updated from time to time. It is the responsibility of the applicant to make his/herself familiar with the Racing Guide and all of its applicable provisions.
- 8. If applicant plans to exercise, train or race a horse on the racetrack he/she must sign the "Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement" as set forth by Plainridge. Such form must be filed with the Racing Office prior to any exercise, training or racing of horses on the Plainridge track.
- 9. All trainers must make arrangements with the racing office prior to shipping in to the barn area.
- 10. All individuals and horses entering the grounds of Plainridge must be signed in.

- 11. Private veterinarians, other than the designated Lasix veterinarian, are not permitted on the grounds of Plainridge on race dates unless approved in advance by the Judges. ALL Lasix administration must be done on-site and by the designated Lasix Veterinarian. NO EXCEPTIONS.
- 12. Only individuals aged 16 or older, licensed by the Massachusetts Gaming Commission Racing Division, and with an interest in a horse competing on that race date, may enter the backstretch, ship-in and Paddock areas of Plainridge. Commission licenses must be visible at all times.
